# Section 4. First aid measures

#### **Description of necessary first aid measures**

Eye contact : Immediately

: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10

# Methods and material for containment and cleaning up

**Small spill**

Large spill

# Section 7. Handling and storage

#### **Precautions for safe handling**

**Protective measures** 

Put on appropriate personal protective equipment (see Section 8). Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing vapour or mist. Avoid release to the environment. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

#### Advice on general occupational hygiene

Store in accordance with local regulations. #### Gloves

## **OLD LEAD-BASED PAINTS:**

When surfaces are to be prepared for painting, account should be taken of the age of the property and the possibility that lead-pigmented paint might be present. There is a possibility that ingestion or inhalation of scrapings or dust arising from the preparation work could cause health effects. As a working rule you should assume that this will be the case if the age of the property is pre 1960.

Where possible wet sanding or chemical stripping methods should be used with surfaces of this type to avoid the creation of dust. When dry sanding cannot be avoided, and effective local exhaust ventilation is not available, it is recommended that a dust respirator is worn, that is approved for use with lead dusts, and its type selected on the basis of the COSHH assessment, taking into account the Workplace Exposure Limit for lead in air.
